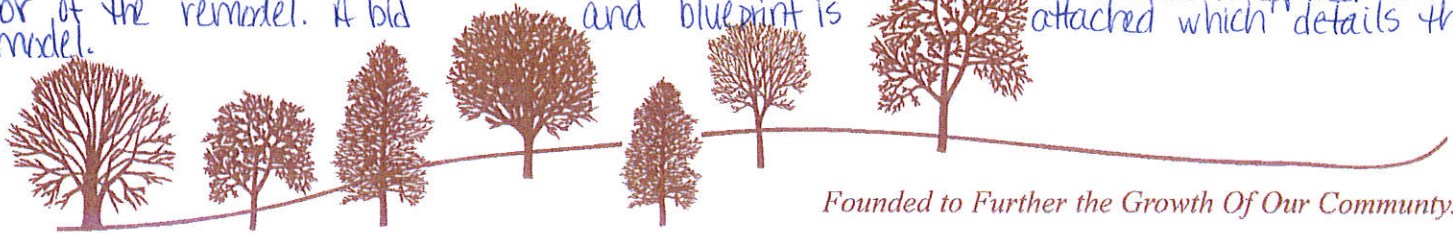
Organization's Purpose Family Advocates, Inc. provides prevention and intervention services to victims of domestic violence, sexual assault, child abuse, and elder abuse in Grant, Iowa, and Lafayette Counties in Southwestern Wisconsin.

Describe the reason for this grant request in the space below:

Family Advocates, Inc. provides emergency shelter to women and children who are seeking safety from an abusive environment. The shelter facility is located in Grant County; however, it provides housing to residents of Grant, Iowa, and Lafayette Counties as well as the surrounding area. The shelter kitchen is used as communal living space for those residing at the shelter. The cupboards, countertops, sink, and appliances are aged and in need of replacement. This application is to request funding for a kitchen remodel which includes the replacement of the countertops, cupboards, double sink, and faucet. Additionally, a used, but updated, stove and refrigerator are being donated to the agency to replace the old appliances. A licensed electrician will be donating his time to connect the new stove as well. A discount application continued on next page has also been applied for the labor of the remodel. A bid and blueprint is attached which details the remodel.

A. Supporting Information

1. Specific use of grant:
 - a. This grant will be used to remodel the kitchen at the shelter facility. Cupboards, countertops, the sink, and the faucet will be replaced.
2. Time schedule:
 - a. Once awarded grant funds, the contractor will begin the remodel.
3. Other sources of funding:
 - a. A used stove and refrigerator are being donated along with labor from a licensed electrician. Additionally, the contractor has given a discount to the labor costs of the remodel.
4. Describe the effect of postponing your request to another time:
 - a. Postponing the project will create hardship in that the current stove does not work properly. The refrigerator is not in good working condition for energy efficiency. The cupboards and countertops will continue to decline in condition and functionality.
5. Describe who, when, how, and where will the effects of this grant be felt:
 - a. Victims of abuse who utilize the shelter facility will benefit from having a more livable environment with an updated kitchen. Everyone deserves a nice place to live even if it is temporary. With these updates, the kitchen will function better and more space will be available for countertop usage. The stove replacement will create a safer and more efficient means to make meals for individuals and families. Without the remodel, the stove will not be able to be replaced as we currently have a standalone stove with burners in a different location. The stove that is being donated has a range top. The effects of this grant will be felt immediately following the remodel. Family Advocates, Inc. has been fortunate to secure the contractor at a discounted rate, an electrician to donate his skills and time, and a cost free replacement of the stove and refrigerator.

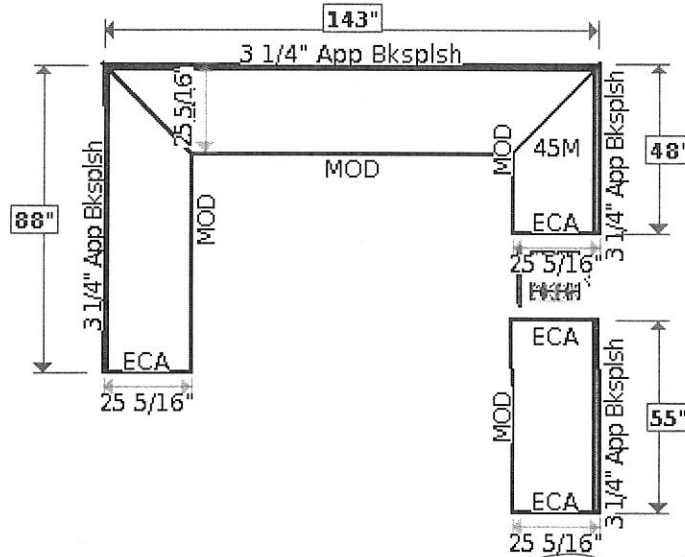


