Organization's Purpose Our purpose and original goal was to add on to our home to better assist our family with space and to give our 4 year daughter her own bedroom.

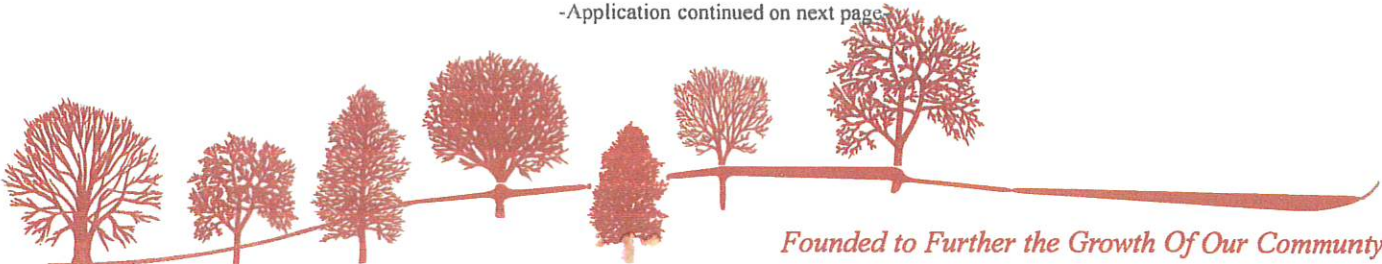

ADJUDGED, ORDERED, and DECREED that:


- a. Plaintiff's Motion for Default Judgment is GRANTED;

THIS IS A FINAL ORDER. THIS MATTER IS ENDED.


