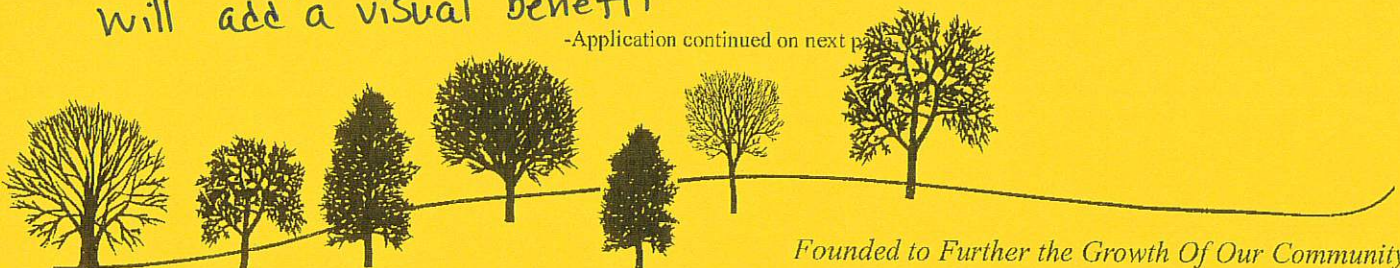

We will be using this grant to help purchase the supplies for the landscaping. The supplies will not only include the plants themselves but will also include supplies like landscaping bricks and mulch. Remaining sources of funding will be coming from the club account. Our club account is funded from member dues and assorted fundraisers. We are hoping to not have to use our full account balance as we do try to participate in other club activities that do require funds. We are also planning to reach out to companies and ask if they would consider selling the materials to us at a discounted cost. We do estimate that the plants alone will cost close to or over \$500.

We would like to start this project in the late spring of 2026 with a goal to have it completed in full by the end of the summer of 2026. We will work in small sections once we start so as to ensure the area still maintains a suitable appearance and does not become messy.

We would prefer to operate within this timeframe due to several older members who are graduated or have recently graduated. We would like to be able to still utilize their leadership in completing this project.

The Montfort Community building is home to the village library and office. Additionally, the ARDC meals are served there. The community hosts assorted events for Christmas and Easter. Individuals are also able to reserve the space for private events. With all this activity, we would like to improve the landscaping to help the building feel more inviting and welcoming. This building is also across the street from the main park where events are also held. This will help to improve the overall appeal of the area.
